APPLICATIONS: Recommended use for berthing areas, crew gathering stations, passage way, gyms, mess decks, operations dept., supply dept. heads (restrooms), showers, medical department, patient rooms and all other open spaces to disinfectant and sanitize hard surfaces to greatly reduce the risk of cross contamination. Effective on tables, chairs, counter tops, sinks, showers, floors, walls and horizontal surfaces. Neutral pH range at use dilution.

DIRECTIONS FOR USE

1. Always dilute product properly. It is a violation of federal laws to use this product in a manner inconsistent with its labeling. Dilute 1:64 (2 oz. per gal.) for daily cleaning and disinfecting.
2. Apply with cloth, mop or mechanical spray device. **Allow surface to remain wet for 10 minutes.**
3. Apply to floors with a clean cotton mop, **allowing floors to remain wet for 10 minutes.** Change solution often to avoid cross-contamination. No rinsing required.
4. All gross blood spills and OPIM should be decontaminated and disposed of according to the Blood Borne Pathogen Standard. For more information contact your local OSHA office or sales representative.
